# 2024

#### August 31

GAGV continues to engage in discovery in Mexico's landmark lawsuit against gun dealers in Arizona. The lawsuit is the first brought by a sovereign nation against gun dealers, and is part of GAGV's legal strategy to stop gun trafficking to Mexico at its gun industry source.



### July 2

GAGV files first <u>amicus brief</u> in U.S. Supreme Court that argues that U.S. gun policy causes harm to other nations, and those international effects should be considered. The brief, in Garland v. Vanderstok, argued that ATF has the statutory authority to regulate ghost guns, and that excluding ghost guns from the firearms that the ATF can regulate will have immense negative consequences in the U.S. and abroad and will harm the U.S.'s global standing.

# April 12

#### August 12

Indiana judge rules that state law intended to dismiss the City of Gary's decades-long lawsuit against gun manufacturers is unconstitutional, allowing case to proceed. GAGV is cocounsel with Brady, Perkins Coie, and other counsel in the case.



### June 24

In response to the U.S. Supreme Court upholding the ban on domestic abusers from possessing firearms, GAGV <u>repeated</u> its call to overturn the Bruen decision, saying, "The Second Amendment madness must end."

# April 9

GAGV <u>argues</u> on behalf of the plaintiffs in Gustafson v. Springfield Armory before the Supreme Court of Pennsylvania. The lawsuit is the first in which an appeals court has <u>ruled</u> that PLCAA, the gun industry shield law, is unconstitutional.

# March 25

In a groundbreaking legal victory, a federal trial court in Arizona <u>rules</u> that the Government of Mexico can proceed in its landmark lawsuit against five gun dealers in that state. GAGV is co-counsel for Mexico.

# February 22

GAGV argues on behalf of Mexico against dismissal of <u>Estados Unidos</u> <u>Mexicanos v. Diamondback Shooting</u> <u>Sports, Inc., et al.</u>, in Arizona federal court. This is the first hearing in the first lawsuit by a sovereign nation against gun dealers.



### January 22

In a monumental victory, GAGV's appeal on behalf of Mexico in <u>Estados</u> <u>Unidos Mexicanos v. Smith & Wesson</u> <u>Brands Inc., et al.</u>, prevails, when the Court of Appeals for the First Circuit allows Mexico to move forward with its lawsuit against gun manufacturers. This landmark decision is the most important one so far in gun litigation.

The decision resulted in massive media coverage, including the <u>New</u> <u>York Times</u>, <u>CNN</u>, <u>NPR</u>, <u>Forbes</u>, the <u>Boston Globe</u>, a New Yorker profile, and many more – in the U.S. and abroad.

Newsweek publishes GAGV's op-ed, "<u>Mexico</u> <u>May Save Us From Our Own Crazy Gun</u> <u>Laws</u>."





GAGV submits <u>a report</u> to the United



Nations Office of the High Commissioner for Human Rights on the "impact of arms transfers, including the diversion of arms and unregulated or illicit arms transfers, on the enjoyment of human rights, with a focus on the role of access to information in preventing, mitigating and responding to the negative human rights impact thereof."

# November 28

GAGV and the Civil and Human Rights Clinic at George Washington University Law School <u>testify</u> before the Inter-American Commission on Human Rights on gun industry practices and weak U.S. gun laws that contribute to violence and human rights violations in the Americas.

# November 9

GAGV files the <u>Lawsuit for Survival</u> against the United States in the Inter-American Commission on Human Rights. Filed on behalf of Manny and Patricia Oliver and their son Joaquin, who died in the 2018 Parkland, FL, school massacre, the suit claims that the U.S. failed to protect people's right to live free from gunfire and asks the IACHR to pressure the U.S. to strengthen its gun laws.

As part of the Lawsuit for Survival, GAGV also

- Started an online <u>petition</u> to the IACHR in support of the lawsuit;
- Co-wrote, with Manny Oliver, an <u>op-ed</u> about the lawsuit that appeared in the Boston Globe;
- Placed a full-page ad about the lawsuit that ran twice in the Washington Post
- Worked with a creative agency to create <u>90</u>-, <u>30</u>-, and <u>15</u>-second videos about the lawsuit plus a one-minute <u>explainer</u>.

# August 30

GAGV files <u>a brief</u> in the Pennsylvania Supreme Court in *Gustafson v. Springfield Armory*, which reviews the first appellate decision to find the U.S. gun industry protection law (PLCAA) unconstitutional. GAGV is lead counsel.

## August 21

GAGV files <u>a brief</u> in the <u>Inter-American</u> <u>Court of Human Rights</u> in support of Mexico's <u>request</u> for an opinion on human rights implications of gun industry practices.



# July 24

GAGV <u>argues</u> Mexico's appeal of <u>Estados</u> <u>Unidos Mexicanos v. Smith & Wesson Brands</u> <u>Inc., et al.</u> in the U.S. Court of Appeals for the 1st Circuit.



### August 21

GAGV files the first <u>amicus brief</u> by a major gun violence prevention group in the U.S. Supreme Court to argue that its pro-gun rights decisions in <u>Heller</u> and <u>Bruen</u> should be reversed.

### July 10

GAGV, Mexico and GTOC host <u>a side</u> <u>event</u> in Geneva, Switzerland, on gun industry' practices as a human rights concern at the <u>53rd session</u> of the U.N. Human Rights Council.



#### June 28

The Hill publishes GAGV's op-ed, "<u>Hey,</u> <u>SCOTUS — the right to life trumps the right</u> <u>to own a gun</u>."



# May 9

Newsweek publishes GAGV's op-ed, "<u>Awash</u> in U.S. Guns and Gun Violence, Caribbean Leaders Are Fighting Back."

# April 17

GAGV <u>participates</u> in the Caribbean Community (CARICOM) regional symposium on "<u>Violence as a Public Health Issue - The</u> <u>Crime Challenge</u>" in Trinidad and Tobago.



# March 15

# May 31

GAGV <u>testifies</u> at a <u>special meeting</u> of the Permanent Council of the Organization of American States on human rights and the role of arms companies.



# May 5

GAGV participates in a <u>Constructive</u> <u>Dialogue on Firearms</u> held by the United Nations Office on Drugs and Crime in Vienna, Austria.

# April 13

#### February 19-25
